In support of S.B. 432 An Act Concerning State Contracts with Nonprofit Human Services Providers

Good afternoon, Senator Flexer, Representative Blumenthal, Senator Sampson, Representative Mastrofranceso and members of the Government Administration & Elections Committee:

Thank you for holding this public hearing today. The Connecticut Association for Community Action (CAFCA) is the state association that works with Connecticut's nine Community Action Agencies (CAAs), the state and federally designated anti-poverty agencies that provide a wide variety of services to nearly 200,000 low- and moderate-income people in all 169 cities and towns across the state. More information about Community Action Agencies is included at the end of this testimony.

CAFCA supports this bill, which would take several steps to improve the issues nonprofits face as we contract with the state to deliver essential health and human services. Specifically, this bill:

• Directs OPM to review contract rates and determine whether they adequately compensate nonprofit providers;

• Requires OPM to review all reports nonprofits are required to file, and eliminate or consolidate any that are unduly burdensome or duplicative;

• Requires all contracting agencies to render payment for services within 30 days;

• Requires OPM and the Comptroller to review and detect inefficiencies with the CORE-CT system.

Community Action Agencies (CAAs) provide vital health and human services to some of the most vulnerable individuals and households across the state. Unfortunately, the ability to provide these services to residents of Connecticut is often put in jeopardy due to the challenges that nonprofits face as a result of the largely inefficient, and ineffective state contracting process and the associated payment delays that this causes. Contract and payment delays are systemic and longstanding problems that cross many state agencies. Community Action Agencies across the state currently have multiple contracts that have been pending execution since before the start of the fiscal year. In most instances the CAAs have continued to provide services by taping into lines of credit or reserves in order to ensure the continuity of services for these vital programs. This is not a sustainable practice and threatens both the availability of these essential services to vulnerable Connecticut residents and the fiscal well-being of non-profit human service providers.

We also appreciate that the bill directs the Office of Policy and Management to evaluate whether the rates state agencies pay for services are adequately compensating nonprofits for the services that they provide. While there have been some rate adjustments over time, there are still far too many that have not been adjusted in many years, while service requirements, reporting and tracking expectations have only increased. The time has come to review and change the state contracting and payment process and this bill will go a long way in initiating that change.
