## In opposition to House Bill 6926: An Act Concerning Funding For The Residential Energy Preparation Services Program

Distinguished Chairpersons, Vice-Chairpersons, Ranking Members, and Members of the Energy & Technology Committee:

Thank you for holding this public hearing today. The Connecticut Association for Community Action (CAFCA) is the state association that works with Connecticut's Community Action Agencies (CAAs), the state and federal designated anti-poverty agencies serving over 200,000 low-income people in all 169 cities and towns. More information about Community Action Agencies is included at the end of this testimony.

CAFCA opposes this bill, which eliminates \$8 million dollars from the Low Income Home Energy Assistance Program (LIHEAP) to fund the Residential Energy Preparation Services (REPS) program.

We know first-hand the importance of providing energy support to low-income families. Community Action Agencies partner with the Department of Social Services (DSS) to raise awareness of and enroll people in the Connecticut Energy Assistance Program (CEAP, Connecticut's version of LIHEAP). Last year, CEAP helped over 100,000 families statewide with home heating costs to avoid unnecessary energy crises.

While we support the REPS program and recognize that removing barriers (asbestos, mold, etc.) to enable weatherization work helps families reduce their overall energy costs and stay healthy and safe, funding for the program should not come at the expense of the LIHEAP program and its customers.

LIHEAP customer energy assistance benefit levels have returned to pre-pandemic levels while Connecticut's high energy costs have only gone up, not down. And households with incomes below 100% of the Federal Poverty Level struggling to

(TVCCA) make ends meet spend 26% of their annual income on home energy bills<sup>1</sup>, meaning they're constantly pushed into crisis mode and forced to choose between heating their home and other essential needs like groceries, housing, medical care, and child care. Continued reductions in benefit levels will not meet the energy needs of our most at-risk families, putting them in even greater danger of having to make these choices again and again.

Both LIHEAP and weatherization play a role in keeping families safe and warm, fostering overall health and wellness, and lowering energy bills. But one program should not be sacrificed for the sake of another, and to the detriment of our most vulnerable populations.
